

EXCLUSIVE BEAT LICENSE INQUIRY

XXYFI

All exclusive beat license requests for XXYFI productions are handled on a case-by-case basis. This document outlines baseline terms and pricing expectations before any negotiation or direct contact.

OVERVIEW

Exclusive rights grant the purchasing artist full ownership and sole usage of the selected instrumental. Once sold exclusively, the beat will be permanently removed from all licensing platforms and will no longer be available for any other use or resale.

All productions are created under a professional catalog curated by a multi-platinum, Billboard-charting producer team.

BASE TERMS (NON-NEGOTIABLE STARTING POINT)

- Exclusive leasing rights transfer upon full payment
- Producer retains publishing percentage unless otherwise negotiated
- Beat is removed from all storefronts upon sale
- Artist receives full commercial recording and distribution rights
- Includes WAV file and full trackout stems
- No further licensing of the instrumental after sale
- Level X Entertainment retains a 50% ownership interest in all master recordings created using exclusive licenses for instrumentals produced by Qing XXY. Any commercially released recording utilizing an exclusively licensed beat shall be jointly owned by the Licensee and Level X Entertainment unless otherwise agreed to in writing. Ownership terms remain in effect regardless of distribution method, label involvement, or commercial performance.

SYNC LICENSING NOTICE (IMPORTANT)

A separate synchronization (sync) license is required for any use of the music in:

- Film
- Television
- Commercial advertising
- Video games
- Trailers or branded content
- Any visual media outside of standard music distribution platforms

Sync rights are not included in the exclusive beat license and must be negotiated separately prior to use.

- All synchronization (sync) licensing rights for any instrumental produced by Qing XXY shall be negotiated exclusively through Level X Entertainment. Licensees are not authorized to independently negotiate, grant, sell, or enter into agreements for the use of the instrumental or any derivative recording in film, television, advertising, video games, trailers, branded content, or other audiovisual media. All sync opportunities must be submitted to and approved by Level X Entertainment prior to execution at sync@xyyfi.com

STARTING PRICE

- Exclusive License Starting Price: \$10,000.00 USD

Final pricing may increase based on:

- Beat usage history (if previously leased)
- Artist profile and distribution reach
- Publishing split negotiations
- Label involvement or major release plans

FINAL MIX APPROVAL

All final mixes, masters, and commercially released versions of any music created using a XXYFI instrumental must receive final approval from Level X Entertainment prior to official release or distribution.

This approval process is intended to maintain overall production quality, sonic consistency, and brand standards associated with XXYFI releases.

Failure to obtain final mix approval may result in revocation of licensing privileges or denial of official authorization for release usage.

IMPORTANT NOTES

- Submission of an inquiry does not guarantee acceptance
- All exclusive deals require written agreement before transfer
- No exclusives are finalized without full payment and contract execution
- All negotiations are handled directly and privately

Sample Clearance Responsibility

Licensee acknowledges that they are solely responsible for identifying, obtaining, and maintaining all necessary sample clearances, permissions, and licenses for any third-party copyrighted material incorporated into the final recording. Licensor makes no representations or warranties regarding the clearance status of any samples. Any release, distribution, performance, synchronization, monetization, or commercial exploitation of a recording containing uncleared samples shall be at the Licensee's sole risk and responsibility. Failure to secure all required clearances prior to release may constitute copyright infringement, and Licensee agrees to indemnify and hold Licensor harmless from any claims, damages, liabilities, costs, or expenses arising from the unauthorized use of sampled material.

INQUIRY PROCESS

To request an exclusive license:

- Submit project details and intended use to support@xyfi.com
- Include release plans (if available)
- Provide budget range

Response time may vary based on catalog availability and prior commitments.
